申明 Statement

客户入金前须阅读本申明

Client should have read this statement before deposit

1) 中辉国际期货有限公司（以下简称“中辉国际”）不接受第三方入金。如客户因第三方入金造成的任何延误、损失或纠纷均与中辉国际无关。Zhonghui Int'l Futures Co. Ltd(as“ZHIF”for short) shall not accept third party deposit. ZHIF assume no responsibility for a n y delay, loss(es) or dispute(s) causing by third party deposit.

2) 中辉国际不接受银行本票。ZHIF shall not accept bank note.

3) 中辉国际不接受现金入金。ZHIF shall not accept cash deposit.

4) 客户填写入金申请书时，须填写清晰准确的银行账户信息，且须与客户本人与中辉国际的《开户协议》中填写的银行账户信息一致。如有变更或新增请及时与我司联系，填写《客户资料变更申请书》。

Client shall clear and correct bank account information when filling the Client Deposit Form, and must be the same with the bank account information which provide in their Account Opening Form which they signed with ZHIF. If there is any change or add, please contact us and fill the Clint Information Amendment Form.

5) 客户入金后须保留入金凭证并将相关凭证一起发送至中辉国际以便核查。

Client shall keep all the proofing documents after they deposit and shall send the same to ZHIF for verification.

6) 客户银行转账会产生一定手续费，如客户采取由转账金额扣费方式，手续费将由银行从客户转账资金从扣除，我司将按实收资金入金。

Client will be charged a fee by the bank when you transfer, if you prefer to be deducted in your transfer fund, ZHIF will deposit the amount as we received eventually.

7) 如客户采用支票入金，客户应提供支票副本及入金凭证:

If Client deposit via a cheque, Client shall provide the copy of cheque and transfer voucher.

Note: 请勿将支票存入支票箱。因银行需要处理支票入账，支票汇款到账时间一般需要 2 个工作日。具体时间以银行侧为准。。

Do not deposit the check in the checkbox. Because the bank needs to process the check into the account, it usually takes 2 working days for the check to arrive in the account. The specific time is subject to the bank.
